## **SECTION 1.** Instructions to Bidders

#### 1.1 Background

- 1.1.1 In 2022-23 during the presentation of Budget by Government of Tamil Nadu, an announcement was made in the floor of the assembly that a biodiversity conservation park will be established at Kadambur, near Maraimalainagar, in Chengalpattu district, Tamil Nadu at a cost of ₹300 crore in partnership with Kew Gardens of London. Accordingly, an area of 137.65 hectares of Kadu Poramboke land was selected and transferred to Environment, Climate Change and Forest Department for the development of the Biodiversity Conservation Park.
- 1.1.2 To ensure that the objectives of the Authority are achieved, Tamil Nadu Infrastructure Development Board (TNIDB) (the "Authority") through this RFP proposes to engage a reputed Consultant which shall undertake the "Preparation of a Concept Plan and Detailed Project Report for the Establishment of World Class Biodiversity Conservation Park at Kadambur, near Maraimalai Nagar, Chengalpattu District, Tamilnadu, India" (the "Assignment").

#### 1.2 Validity of the Proposal

1.2.1 The RFP Proposal shall remain valid for a period of 150 (One Hundred and Fifty) days from the last date of submission of the RFP with a provision for extension.

#### 1.3 Brief Description of Selection Process (the "Selection Process")

- 1.3.1 The Authority intends to select a consulting firm/ organisation (the "Consultant") from the consultants who make a Bid (the "Bidder") through a two part (i.e. Technical and Financial Proposal) (the "Proposal") online Selection Process in accordance with the procedure set out herein.
- 1.3.2 In **Technical Proposal**, the eligibility of Bidders will be verified based on the eligibility information mentioned in Data Sheet and provided by the Bidders as per the formats given in this RFP. The Technical Proposal of only those firms found eligible and satisfying the minimum eligibility criteria shall be evaluated and scored based on the marking criteria mentioned in Data Sheet. Such Bidders may be invited to make presentation on the Approach & Methodology, covering all the aspects of TOR, Work Schedule by the Team proposed for the assignment to the Evaluation Committee of the Authority. Team Leader proposed by the Bidder must be present during the presentation. The time schedule and venue for presentation will be intimated to such Bidders by the Authority. Bidders scoring not less than **70%** of the total points (S<sub>1</sub>) in Technical Proposal shall only be qualified for opening of **Financial Proposal**. The Authority shall notify the

Bidders, results of the technical evaluation and invite those who have secured the minimum qualifying mark for opening of the financial proposals indicating the date and time. The financial Proposal of unqualified Bidders shall not be opened.

1.3.3 In Financial Proposal evaluation, the Financial Proposal of shortlisted Bidders shall be evaluated, and the lowest evaluated financial proposal (F<sub>m</sub>) will be given the maximum financial score (S<sub>f</sub>) of 100 points. The financial scores (S<sub>f</sub>) of the other Financial Proposals will be computed as per the formula given below:

 $S_f = 100 \text{ x Fm / F}$ , in which  $S_f$  is the financial score, Fm is the lowest price quoted by any Bidders and F the price of the Proposal under consideration.

1.3.4 The total scores of the Bidders shall be arrived by applying the weights to the Technical and Financial Proposal to select the first ranked Bidder (R1) (the "Selected Bidder"). The remaining Bidders shall be ranked R2, R3 and so forth. The weights given to the Technical and Financial Proposals shall be as per the Data Sheet.

The first ranked Bidder shall be selected for negotiation while the second ranked Bidder shall be kept in reserve.

#### 1.4 Schedule of Selection Process

#### 1.5 Conflict of Interest

- 1.5.1 A Bidder shall not have a conflict of interest that may affect the Selection Process or the Consultancy (the "Conflict of Interest"). Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Authority shall forfeit and appropriate the Bid Security as mutually agreed genuine pre-estimated compensation and damages payable to the Authority for, inter alia, the time, cost and effort of the Authority including consideration of such Bidder's Proposal, without prejudice to any other right or remedy that may be available to the Authority hereunder or otherwise.
- 1.5.2 The Authority requires that the Consultant provides professional, objective, and impartial advice and at all times hold the Authority's interests paramount, avoid conflicts with other assignments or its own interests, and act without any consideration for future work. The Consultant shall not accept or engage in any assignment that would be in conflict with its prior or current obligations to other Authority, or that may place it in a position of not being able to carry out the assignment in the best interests of the Authority. Without limiting the generality of the above, a Bidder shall be deemed to have a Conflict of Interest affecting the Selection Process, if:
  - the Bidder, and any other Bidder, has common controlling shareholders or other ownership interest; provided that this disqualification shall not apply in cases where the direct or indirect shareholding or ownership interest of an Bidder, (or any shareholder thereof having a shareholding of more than 5 per cent of the paid up and subscribed share capital of such Bidder, as the case may be) in the other Bidder, is less than 5% (five per cent) of the subscribed and paid up equity share capital thereof; provided further that this disqualification shall not apply to any ownership by a bank, insurance company, pension fund or a public financial institution referred to in section 4A of the Companies Act, 1956/sub-Section (72) of Section 2 of the Companies Act, 2013. For the purposes of this Clause 1.5.2(a), indirect shareholding held through one or more intermediate persons shall be computed as follows: (aa) where any intermediary is controlled by a person through management control or otherwise, the entire shareholding held by such controlled intermediary in any other person (the "Subject Person") shall be taken into account for computing the shareholding of such controlling person in the Subject Person; and (bb) subject always to subclause (aa) above, where a person does not exercise control over an intermediary, which has shareholding in the Subject Person, the computation of indirect shareholding of such person in the Subject Person shall be undertaken on a proportionate basis; provided, however, that no such shareholding shall be reckoned under this sub-clause (bb) if the shareholding of such person in the intermediary is less than 26% (twenty six per cent) of the subscribed and paid up equity shareholding of such intermediary; or

- b. A constituent of such Bidder is also a constituent of another Bidder; or
- c. Such Bidder receives or has received any direct or indirect subsidy or grant from any other Bidder or its Associate; or
- d. Such Bidder has the same legal representative for purposes of this Bid as any other Bidder; or
- e. Such Bidder has a relationship with another Bidder, directly or through common third parties, that puts them in a position to have access to each other's information about, or to influence the Bid of either or each of the other Bidder; or.
- f. There is a conflict among this and other consulting assignments of the Bidder (including its personnel) and any subsidiaries or entities controlled by such Bidder or having common controlling shareholders. The duties of the Consultant will depend on the circumstances of each case. While providing consultancy services to the Authority for this particular assignment, the Consultant shall not take up any assignment that by its nature will result in conflict with the present assignment; or
- g. A firm which has been engaged by the Authority to provide goods or works or services for a project, and its Associates, will be disqualified from providing consulting services for the same project save and except as per provisions of this RFP; conversely, a firm hired to provide consulting services for the preparation or implementation of a project, and its Members or Associates, will be disqualified from subsequently providing goods or works or services related to the same project, provided further that this restriction shall not apply to consultancy/ advisory services provided to the Authority in continuation of this Consultancy or to any subsequent consultancy/ advisory services provided to the Authority in accordance with the rules of the Authority

For purposes of this RFP, Associate means, in relation to the Bidder, a person who controls, is controlled by, or is under the common control with such Bidder (the "Associate"). As used in this definition, the expression "control" means, with respect to a person which is a company or corporation, the ownership, directly or indirectly, of more than 50% (fifty per cent) of the voting shares of such person, and with respect to a person which is not a company or corporation, the power to direct the management and policies of such person by operation of law or by contract.

#### 1.6 Number of Proposals

1.6.1 No Bidder or its Associate shall submit more than one Bid for the Consultancy.

#### 1.7 Cost of Proposal

1.7.1 The Bidders shall be responsible for all the costs associated with the preparation of their Proposals

and their participation in the Selection Process including subsequent negotiation, visits to the Authority, Project site etc. The Authority will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Selection Process.

#### 1.8 Site visit, verification of information and acknowledgment by the Bidder

- 1.8.1 Bidders are encouraged to submit their respective Proposals after visiting the project site and ascertaining for themselves the site conditions, traffic, location, surroundings, climate, access to the site, availability of drawings and other data, Applicable Laws and regulations or any other matter considered relevant by them. The costs of undertaking such visit shall be borne by the Bidder.
- 1.8.2 It shall be deemed that by submitting the Proposal, the Bidder has:
  - a. Made a complete and careful examination of the RFP;
  - b. Received all relevant information requested from the Authority;
  - c. Acknowledged and accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of the Authority or relating to any of the matters referred to in Clause 1.8.1 above;
  - d. satisfied itself about all matters, things and information, including matters referred to in 1.8.1 herein above, necessary and required for submitting an informed Bid and performance of all of its obligations there under;
  - e. Acknowledged that it does not have a Conflict of Interest; and
  - f. Agreed to be bound by the undertaking provided by it under and in terms hereof.
- 1.8.3 The Authority shall not be liable for any omission, mistake or error on the part of the Bidder in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to RFP or the Selection Process, including any error or mistake therein or in any information or data given by the Authority.

#### 1.9 Right to Cancel this RFP or Reject any Proposal

- 1.9.1 Notwithstanding anything contained in this RFP, the Authority reserves the right to postpone / Cancel this RFP at any point of time without assigning any reason, whatsoever.
- 1.9.2 The Authority reserves the right to reject any Proposal if:
  - a. At any time, a material misrepresentation is made or discovered, or
  - b. The Bidder does not provide, within the time specified by the Authority, the supplemental information sought by the Authority for evaluation of the Proposal.

1.9.3 Misrepresentation/improper response by the Bidder may lead to the disqualification of the Bidder. If such disqualification / rejection occurs after the Proposals have been opened and the highest-ranking Bidder gets disqualified / rejected, then the Authority reserves the right to consider the next ranked Bidder, or take any other measure as may be deemed fit in the sole discretion of the Authority, including annulment of the Selection Process.

#### 1.10 The Submission and Opening of Proposals

- 1.10.1 The Bidders are required to register themselves on the Tamil Nadu e-procurement system portal at <u>URL:https://tntenders.gov.in/nicgep/app</u> and submit soft copies of their proposal electronically using valid Digital Signature Certificates. Bidders may refer to instructions on online proposal submission available on the site at:

- 1.10.2 The Proposal must be submitted online through the e-Procurement process as specified in the RFP.

  The Authority shall not be held liable for any delay in bid submission for any reason whatsoever.
- 1.10.3 The Proposals addressed to the Authority as mentioned in the Data Sheet shall be submitted in two parts following the formats/schedules given for respective proposal.
- 1.10.4 The first part Technical Proposal should contain the scanned copy of the following documents:

- a. Form TECH A Minimum Eligibility Experience
- b. Form TECH B Consortium Agreement
- c. Form TECH 1 Technical Proposal Submission Form
- d. Form TECH 2 Particulars of the Bidder
- e. Form TECH 3 Power of Attorney for Signing of Proposal
- f. Form TECH 4 Summary of Bidder's Experience
- g. Form TECH 5 Bidder's Experience
- h. Form TECH 6 Work Plan and Approach and Methodology Proposed
- i. Form TECH 7 Work Schedule Form
- j. Form TECH 8 Team Composition and Task Assigned
- k. Form TECH 9 Curriculum Vitae of Key Personnel
- 1.10.5 The Proposals must be properly signed by the authorized representative (the "Authorized Representative") as detailed below:
  - a. In case of Consortium, by the authorised representative of the Lead Member

- b. By a partner, in case of a partnership firm and/or a limited liability partnership; or
- c. By a duly authorized person holding the Power of Attorney, in case of a Limited Company/Private Limited Company or a Corporation; or
- d. By a person authorized through a General or Specific Board Resolution for signing proposals; Certified True Copy of such resolution in the hands of a Director of the Company shall be submitted for this purpose.

The power of attorney, if applicable should be certified under the hands of a partner or director of the Bidder and notarised by a notary public in the form specified in Section 4 and shall accompany the Proposal.

1.10.6 The Second Part - Financial Proposal should contain the contents as below:

#### Financial Proposal

- a. FORM FIN-1: Financial Proposal Submission Form (*To be submitted in BOO format only*)
- 1.10.7 A Price Bid format has been provided with the RFP document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the Price Bid file (BOQ), open it and complete the cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the Price Bid file is found to be modified by the bidder, the bid will be rejected.
- 1.10.7.1 While submitting the Financial Proposal, the Bidder shall ensure the following:
  - a. All the costs associated with the assignment shall be included in the Financial Proposal. These shall normally cover remuneration for all the Personnel (Expatriate and Resident, in the field, office etc.), accommodation, air fare, equipment, printing of documents, surveys, geo-technical investigations etc. The total amount indicated in the Financial Proposal shall be without any condition attached or subject to any assumption and shall be final and binding. In case any assumption or condition is indicated in the Financial Proposal, it shall be considered non-responsive and liable to be rejected.
  - b. The Financial Proposal shall take into account all expenses and tax liabilities except GST which shall be paid at applicable rates. For the avoidance of doubt, it is clarified that all taxes except GST shall be deemed to be included in the costs shown in the Financial Proposal. Further, all payments shall be subject to deduction of taxes at source as per Applicable Laws.
  - c. Costs shall be expressed in INR.

- 1.10.8 The Bidders are advised in their own interest to ensure that completed Proposals are submitted well before the dates and time stipulated in the document. The Authority shall not be responsible for any delay in submission of the proposal due to any reason whatsoever.
- 1.10.9 Prior to evaluation of Proposals, the Authority will determine whether each Proposal is responsive to the requirements of the RFP. The Authority may, in its sole discretion, reject any Proposal that is not responsive hereunder. A Proposal shall be considered responsive only if:
  - a. The Technical Proposal is received in the forms specified at Section 4;
  - b. It is accompanied by the Power of Attorney as specified in Form 3 or such other document stipulated in Clause 1.10;
  - c. It contains all the information (complete in all respects) as requested in the RFP;
  - d. It does not contain any condition or qualification.
  - e. The Technical proposal does not contain any information regarding Financial Quote/Proposal
- 1.10.10 The proposals will be opened online by the Authorised Representative of the Authority as per schedule mentioned in Clause 1.4.

#### 1.11 Clarifications

1.11.1 Bidders requiring any clarification on the RFP and its terms and conditions may send their queries to the email id mentioned in the data sheet so as to reach before the date mentioned in the Schedule of Selection Process at Clause 1.4. The email shall clearly bear the following subject:

The Authority shall endeavour to respond to any queries or request for clarifications received from the Bidders within the date mentioned as per Clause 1.4 but not later than 7 (Seven) Days prior to the Bid Submission End Date . The Authority will post the reply to all such queries on the Website mentioned in the Data Sheet

The Authority shall endeavour to respond to any further queries/request for clarifications received up to 48 (Forty-eight) hours prior to the Bid Submission End Date. The Authority will post the reply to all such queries, addendum/corrigendum, if any on the Website mentioned in the Data Sheet. No Separate Advertisement for Addendum/Corrigendum/extension of date will be published in the Newspapers.

Any queries relating to the *process of online proposal submission or queries relating to NIC* **Portal** in general may be directed to the Helpdesk through mail ID – support-eproc@nic.in. The

contact number for the helpdesk is 0120-4711508, 0120-4001002, 0120-40010025, 0120-6277787.

#### 1.12 Amendment of RFP

- 1.12.1 At any time prior to the deadline for submission of Proposal, the Authority may, for any reason, whether at its own initiative or in response to clarifications requested by an Bidder, modify the RFP document by the issuance of Addendum/Amendment and posting it on the website. All such amendments will be binding on all Bidders.
- 1.12.2 In order to afford the Bidders a reasonable time for taking an amendment into account, or for any other reason, the Authority may, in its sole discretion, extend the Bid Submission End Date.

#### 1.13 Language

1.13.1 The Proposal with all accompanying documents (the "Documents") and all communications in relation to or concerning the Selection Process shall be in English language and strictly on the forms provided in this RFP. No supporting document or printed literature shall be submitted with the Proposal unless specifically asked for and in case any of these Documents is in another language, it must be accompanied by an accurate translation of the relevant passages in English, in which case, for all purposes of interpretation of the Proposal, the translation in English shall prevail.

#### 1.14 Retender/Resubmission of Proposal

- 1.14.1 In case the RFP is retendered, then it is mandatory for the Bidder to submit its Bid again on the e-procurement portal.
- 1.14.2 After submission of the Bid, and before the scheduled closing time for submission, if a Bidder wishes to make changes to the Bid, he can do so by clicking the "Resubmit" option.
- 1.14.3 Bidders shall not be allowed to withdraw the proposal any time after submission of Proposal.

#### 1.15 Evaluation Committee

- 1.15.1 The evaluation committee appointed by the Authority will carry out its evaluation of the Technical and Financial Proposals as per the RFP.
- 1.15.2 The Evaluation Committee appointed by the Authority will evaluate the Technical Proposals after evaluation of minimum eligibility criteria as given in the Data Sheet.
- 1.15.3 The committee will carry out evaluation of proposals meeting the minimum eligibility criteria as per the point system specified in the Data Sheet below. Each responsive proposal will be attributed

a technical score (St)

#### 1.16 Clarifications during Evaluation

- 1.16.1 To facilitate evaluation of Proposals, the Authority may, at its sole discretion, seek clarifications from any Bidder regarding its Proposal. Such clarification(s) shall be provided within the time specified by the Authority for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be through e-procurement portal.
- 1.16.2 If a Bidder does not provide clarifications sought under Clause 1.16.1 above within the specified time, its Proposal shall be liable to be rejected. In case the Proposal is not rejected, the Authority may proceed to evaluate the Proposal by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall be barred from subsequently questioning such interpretation of the Authority.

#### 1.17 Confidentiality

1.17.1 Information relating to the examination, clarification, evaluation, and recommendation for the selection of Bidders shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional adviser advising the Authority in relation to matters arising out of, or concerning the Selection Process. The Authority will treat all information, submitted as part of the Proposal, in confidence and will require all those who have access to such material to treat the same in confidence. The Authority may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/or the Authority.

#### 1.18 Negotiations

- 1.18.1 The aim of the negotiations is to reach agreement on all points and initial a draft contract by the conclusion of Negotiations.
- 1.18.2 Negotiations with selected Bidder will commence with a discussion of technical proposal, the proposed methodology (work plan), costing, staffing and any suggestions made to improve the TOR. Agreement must then be reached on the final TORs, the staffing and staff months, logistics and reporting.
- 1.18.3 The Authority will not consider substitutions in the proposed key personnel during contract negotiations unless both parties agree that undue delay in the selection process makes such substitution unavoidable or for reasons such as death or medical incapacity. Any proposed substitute shall have equivalent or better qualifications and experience than the original candidate and be

- submitted by the successful Bidder within the period specified in the letter of invitation to negotiate.
- 1.18.4 Any need for substitution as a result of negligence on the part of the successful Bidder such as non-confirmation of availability of key personnel before submission of proposal may result in disqualification of the successful Bidder and bid security of such Bidder be forfeited.
- 1.18.5 Changes agreed upon will then be reflected in the draft contract, including all tax liabilities and all costs, etc.
- 1.18.6 The Contract will be awarded after successful negotiations, with the Selected Bidder. In the event the Selected Bidder fails to reconfirm its commitments during negotiations such that there arises a material deviation in the technical proposal as evaluated by the authority, then the authority reserves the right to disqualify the proposal of the Selected Bidder and designate the next ranked Bidder as the Selected Bidder and invite it for negotiations.
- 1.18.7 The Contract will be awarded after successful negotiations, with the qualified/ Selected Bidder.

#### 1.19 Substitution of Key Personnel

1.19.1 The Authority expects all the Key Personnel specified in the Proposal are to be available during implementation of the Scope of Work mentioned in this RFP. The Authority will not consider any substitution of Key Personnel except under compelling circumstances beyond the reasonable control of the Consultant such as retirement, death, medical incapacity among others, of personnel. Such substitution shall be limited to a maximum of two Key Personnel other than Team Leader subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority. Any subsequent substitution of key personnel so replaced would call for reduction of remuneration by 2% of the Contract Value for the balance payment. Substitutions undertaken at the time of contract negotiations shall be counted while calculating the number of substitutions under this clause. Requests by Consultant for replacement of Team Leader may be considered by the authority for situation beyond the reasonable control of the consultant and allowed based on merits of the case so determined by the Authority, subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority. The Authority may impose, at its discretion, reduction of remuneration of up to 5% of the Contract Value for the balance payment. The Authority reserves the right to instruct the Consultant to replace the key personnel during negotiation/implementation stage. such replacement shall not be considered for reduction of Contract Value. Inability of consultant to deploy Team Leader for the assignment will be grounds for termination by the Authority.

#### 1.20 Award of Consultancy

1.20.1 After selection, a Letter of Award (the "LOA") shall be issued, in duplicate, by the Authority to the Selected Bidder (the "Consultant") and the Selected Bidder shall, within 7 (seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. Draft Letter of Award Format is provided in Section 5 as Annexure B. In the event the duplicate copy of the LOA duly signed by the Selected Bidder is not received by the stipulated date, the Authority may, unless it consents to extension of time for submission thereof, appropriate the Bid Security of such Bidder for damages suffered by the Authority on account of failure of the Selected Bidder to acknowledge the LOA, and the next highest ranking Bidder may be invited for negotiations.

#### 1.21 Execution of Contract

1.21.1 After acknowledgement of the LOA as aforesaid by the Selected Bidder, it shall execute the Contract within the period of 30 days. The Selected Bidder shall not be entitled to seek any deviation in the Contract.

#### 1.22 Commencement of Assignment

1.22.1 The Consultant shall commence the Services within 7 (seven) days of signing of contract or such other date as may be mutually agreed. If the Consultant fails to either sign the contract as specified in Clause 1.21 or commence the assignment as specified herein, the Authority may invite the next ranked Bidder for negotiations. In such an event, the Bid Security of the Selected Bidder shall be forfeited and appropriated in accordance with the provisions of Clause 1.24.

#### 1.23 Proprietary Data

1.23.1 Subject to the provisions of Clause 1.17, all documents and other information provided by the Authority or submitted by a Bidder to the Authority shall remain or become the property of the Authority. Bidders and the Consultant, as the case may be, are to treat all information as strictly confidential. All information collected, analysed, processed or in whatever manner provided by the Consultant to the Authority in relation to the Consultancy shall be the property of the Authority.

#### 1.24 Bid Security

- 1.24.1 The Bidder shall furnish as part of its Proposal, a bid security as per details mentioned in Section 2 Data Sheet (the "**Bid Security**"), returnable not later than 60 (Sixty) days after the expiration of the Bid validity period, including any extension thereof, or 60 (Sixty) days after the issuance of the Letter of Award, whichever is earlier. The Selected Bidder's Bid Security shall be returned upon the Bidder signing the Contract.
- 1.24.2 The Authority shall not be liable to pay any interest on the Bid Security and the same shall be interest free.
- 1.24.3 The Bidder, by submitting its Bid pursuant to this RFP, shall be deemed to have acknowledged that without prejudice to the Authority's any other right or remedy hereunder or in law or otherwise, the Bid Security may be forfeited and appropriated by the Authority for damages payable to the Authority for, inter alia, the time, cost and effort of the Authority in regard to the RFP including the consideration and evaluation of the Proposal under the following conditions:
  - a. If a Bidder engages in any of the Prohibited Practices specified in Clause 1.26 of this RFP;
  - b. In the case of the Selected Bidder, if the Bidder fails to reconfirm its commitments during negotiations as required vide Clause 1.18;
  - c. In the case of a Selected Bidder, if the Bidder fails to accept the LOA as specified in Clause 1.20
  - d. In the case of a Selected Bidder, if the Bidder fails to sign the Contract or provide the performance security within the specified time limit as specified in Clauses 1.21 and 1.25 respectively; or
  - e. If the Bidder is found to have a Conflict of Interest as specified in Clause 1.5.
  - f. if the firm has furnished incorrect information on qualification and experience.

#### 1.25 Performance Security

- 1.25.1 Prior to signing of contract, the Selected Bidder shall furnish Performance Security to the Authority, for an amount mentioned in the Data Sheet. The Performance Security shall be in the form of Demand Draft/Bank Guarantee issued by Scheduled Commercial Banks in India, in the name of the Authority mentioned in the Data Sheet, as per the format attached *in Draft Contract*.
- 1.25.2 In case of Bank Guarantee, this Performance Security shall remain valid for a period of 90 (Ninety) days beyond the date of completion of all contractual obligations by the Selected Bidder. The validity of performance security will be extended according to the extension of contract period as per the contract executed. The Performance Security shall be in the prescribed form as provided in this RFP.
- 1.25.3 The Penalty for error/variation and Penalty for delay shall be recovered by appropriation from the Performance Security or otherwise as provided in the Draft Contract.

- 1.25.4 If Selected Bidder fails to fulfil its obligations in terms of the Contract, the Performance Security may be invoked by the Authority as compensation.
- 1.25.5 If any amendment is issued to the Contract, the Selected Bidder shall, within 21 (twenty-one) days of issue of the amendment, furnish the corresponding amendment to the Performance Security (as necessary), rendering the same valid in all respects in terms of the contract, as amended.
- 1.25.6 The Authority shall have the right to appropriate the Performance Security, in whole or in part, in the event of breach of Contract or for recovery of penalty. Subject to the above sub-clauses, the Authority will release the Performance Security without any interest to the Selected Bidder on completion of the firm's contractual obligations.

#### 1.26 Fraud and Corrupt Practises

- 1.26.1 The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Selection Process. Notwithstanding anything to the contrary contained in this RFP, the Authority will reject a Proposal without being liable in any manner whatsoever to the Bidder, if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "Prohibited Practices") in the Selection Process. In such an event, the Authority will, without prejudice to its any other rights or remedies, forfeit and appropriate the Bid Security, as mutually agreed genuine pre-estimated compensation and damages payable to the Authority for, inter alia, time, cost and effort of the Authority, in regard to the RFP, including consideration and evaluation of such Bidder's Proposal.
- 1.26.2 For the purposes of this Clause, the following terms shall have the meaning hereinafter respectively assigned to them:
  - a. "corrupt practice" means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of any person connected with the Selection Process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of the Authority who is or has been associated in any manner, directly or indirectly with the Selection Process or the LOA or has dealt with matters concerning the Contract or arising there from, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the Authority, shall be deemed to constitute influencing the actions of a person connected with the Selection Process; or (ii) save as provided herein, engaging in any manner whatsoever, whether during the Selection Process or after the issue of the LOA or after the execution of the Contract, as the case may be, any person in respect of any matter relating to

- the Assignment or the LOA or the Contract, who at any time has been or is a legal, financial or technical consultant/ adviser of the Authority in relation to any matter concerning the Assignment;
- b. "**fraudulent practice**" means a misrepresentation or omission of facts or disclosure of incomplete facts, in order to influence the Selection Process;
- c. "coercive practice" means impairing or harming or threatening to impair or harm, directly or indirectly, any persons or property to influence any person's participation or action in the Selection Process;
- d. "undesirable practice" means (i) establishing contact with any person connected with or employed or engaged by the Authority with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or (ii) having a Conflict of Interest; and
- e. "Restrictive practice" means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Selection Process.

#### SECTION 3. TERMS OF REFERENCE

#### 3.1 Background

During the Budget of 2022-23, the Government of Tamil Nadu announced establishing a World Class Biodiversity Conservation Park at Kadambur, near Chennai. The Biodiversity Conservation Park is planned in an area of 137.65 hectares in partnership with Kew Gardens of London. The entire land for the project is in possession of the Environment, Climate Change and Forest Department, Government of Tamil Nadu.

In this regard, Tamil Nadu Forest Department (TNFD) seeks the services of well reputed national and international consultancy firms with experience in developing large scale Botanical Gardens and Biodiversity Parks within and outside the country for the preparation of a Concept Plan and DPR for the project. The study is key to enabling the planning, design and development of Biodiversity Conservation Park that will combine activities such as recreation, conservation, environmental education, scientific research and aims to become a centre for scientific research and education with a world class plant collection. TNFD has required assistance from TNIDB for selection of consultancy firm for the Assignment.

Tamil Nadu Infrastructure Development Board (TNIDB), set up under the Tamil Nadu Infrastructure Development Act (TNID Act) 2012, is the nodal agency for infrastructure development in the State of Tamil Nadu. The Board coordinates infrastructure development activities in the State and facilitate projects undertaken solely by Government institutions as well as projects undertaken through Public-Private Partnerships (PPP).

Tamil Nadu Infrastructure Development Board (TNIDB) through this RFP proposes to engage a reputed Consultant which shall undertake the "Preparation of a Concept Plan and Detailed Project Report for the Establishment of World Class Biodiversity Conservation Park at Kadambur, near Maraimalai Nagar, Chengalpattu District, Tamilnadu, India"



- Water Body: A water body situated at the south eastern direction adjacent to the project site collects the storm water run-off.
- High Tension Structures: Three high tension over head electrical lines criss-cross the site from the Kalivanthapattu Power Grid sub-station located at the eastern side of the project site. Out of this three, two lines are passing from the east to southern side and the third passes from the east to the north western corner.

#### 3.4 Objective of the Assignment

The selected site at Kadambur is spread over 137.65 ha and is cradled by the urban Settlements of Maraimalai Nagar municipality, Mahindra world city and Oragadam Industrial area. The selected site is abetting the Gudalur Reserved Forest which is spread over 1104.52 ha. The Gudalur Reserve Forest has a rich



Biodiversity comprising of 100 - 150 species of plants, 70 - 100 species of birds, around 30 species of Butter flies, 5 - 10 species of mammals and 15 - 20 species of Amphibians and Reptiles. Some of the important medicinal plants exist in this Reserved Forest are *Andrographis paniculata*, *Wrightia tinctoria*, *Terminalia bellerica*, *Terminalia arjuna Azadirachta indica*, *Cissus quadrangularis* etc.,

The objectives of establishing a Biodiversity Conservation Park include:

- i. Develop a 'nature park' to collect, display, conserve the vide variety of flora from across Tamil Nadu and other places.
- ii. Develop a 'botanical enclave' that brings together themes aligned to different regional flora from all over Tamil Nadu ranging from mountains, forests, plateaus, riverine to coastal areas comprising of trees, shrubs, bushes, grasses and every type of botanical species to provide a holistic display of botanical richness and variety of the State.
- iii. Serve as a conservation and education center.
- iv. Benchmarking with successful international Biodiversity Conservation Park or similar initiatives
- v. Establishing herbarium of authentic specimen for identification of plants.
- vi. To create an enclave that can provide a real-time information to the public about the rich biodiversity of the State including indigenous & exotic plants from various agroclimatic regions.
- vii. Develop the facility as an ecotourism destination
- viii. Provide and promote opportunities for small scale enterprises and support local business and services to improve the standard of living of people in their community.
- ix. Evaluate and identify the potential economic and social implications, and benefits of the conservation and sustainable use of local biological resources.

Considering the above objectives, the Consultant is required to:

- a. Prepare the Concept Plan and a Detailed Project Report (DPR) for the establishment of Biodiversity Conservation Park at Kadambur, near Maraimalainagar, Chengalpattu District, Tamilnadu
- b. Prepare the tender documents as per prevailing Government norms and assist the Department in the bid process management.

#### 3.5 Proposed Components for the Project:

The following is an indicative list of the proposed components for the Biodiversity Conservation Park Project.

#### 3.6 Detailed Scope of work

The scope of work entails preparation of a Concept Plan and a Detailed Project Report covering site analysis, surveys, stakeholder consultations, concept plans, external and internal infrastructure assessment, master plan with broad cost estimates, financial analysis, project structuring, implementation framework, preparation of tender documents and bid process management.

#### A. Detailed Site Appreciation and Analysis

#### (i) Site Analysis

The Consultant Team shall make field visits to the Site to ascertain the physical aspects of the Site. The consultant shall carry out an analysis of the identified site and its surroundings. The site analysis

shall include

- Location Study
- Condition of existing roads and traffic pattern
- Land use pattern, Catchment study and Development Control Regulations- building bye laws, development regulations, permitted FAR, etc.
- Existing utilities
- Details of nearby water sources, power, and status of availability for the project
- Identification of environmentally/ecologically sensitive areas

The above information shall be supported with the data reference and maps of relevant scale (wherever applicable).

#### (ii) Field Surveys & Investigations:

#### a) Topographic Survey:

The Consultant shall undertake physical survey (with extent) of the project site and the boundary survey with appropriate coordinates (using DGPS). The details may be provided includes (i) Site survey drawings with all physical features of the site (ii) its approach roads, roads traversing through site and abutting roads, (iii) existing infrastructure networks (electrical, sewerage, telephone, water supply, drainage etc.), (iv) vegetation (trees and shrubs), (v) other physical features like damp areas, pits, rocky areas, hillocks/hills, natural drains, streams and other water bodies etc., and (vii) built-up features.

#### b) Geo-Technical Investigations

Necessary soil investigation shall be carried out at the Site to assess the nature of soil. The soil tests would beundertaken in sufficient detail to arrive site suitability for plants and the safe bearing capacity (design parameter) for civil works.

#### c) Preparation of base map:

The Consultant shall prepare the base map for the project site in (CAD/ Shape format) showing the (i) site boundary with the FMB sketches as obtained from the topographic survey, (ii) existing physical features such as water bodies, streams, rocky areas, built up areas (if any) etc. (iii) contour map with levels of 1 m intervals using plot levels taken at site based on MSL, etc. The Base map shall comprise of various layers as required by the Department (Layout + Topography, Layout + Contour, Layout + Topography + Contour, etc.). The consultant shall submit hard and soft copies of the base map to the department.

#### d) Other Data

In addition, data pertaining to meteorology, hydrology, soil characteristics, etc. may be studied to assess the site suitability for flora and fauna and other project components.

#### B. Benchmarking of Similar Botanical Gardens/ Bio-Diversity Parks

The Consultant shall carry out a detailed Benchmarking study of the successful National / International Botanical Gardens/Bio Diversity Parks in terms of project features, components, development model, management, etc. It is preferable that the benchmarking is focussed on international projects. Through the review and benchmarking exercise, the Consultant shall identify at least 5 (five) signature projects of similar nature and complexity from Indian perspective, on lines of which signature projects can be developed to suit the local/Indian conditions.

- i. Jointly prioritize with the Department a set (atleast 5 No.) of similar International Botanical Gardens/Bio-Diversity parks for benchmarking,
- ii. Conduct secondary research to understand key aspects of each of these Parks, including but not limited to:
  - a. Project Concept
  - b. Salient Features and uniqueness of Garden/Park
  - c. Components
  - d. Amenities and key infrastructure including support infrastructure, business facilitation, etc,
  - e. Sustainability aspects
  - f. Institutional arrangements
  - g. Key differentiators
- iii. Incorporate the best practices of benchmarked Botanical Gardens /Bio-diversity parks in conceptualisation, Master planning and design of the proposed Biodiversity Conservation Park.

#### C. Stakeholders Consultation

The Consultant shall carry out consultation with key stakeholders — wildlife experts, leading academic and research institutions, WWF, IUCN, NGOs, etc. during the conceptualization stage. The Stakeholder consultations may include vision, key features and components, strategic interventions, etc. for the proposed project. The consultant shall involve a representative of the Forest Department in its major stakeholder consultation meetings. A preliminary list of stakeholders may be provided to Department for their suggestions.

#### D. Concept Plan

In this task, the Consultant shall conceptualize the projects and prepare the Concept Plans. The Concept Plan shall consider the intensity of the proposed Biodiversity Conservation Park and provide a guidance to the future expansion of new gardens and collections. The Concept Plan shall highlight the various elements for the Biodiversity Conservation Park taking cognisance of the park setting, local character, topography, native species, flora and fauna, etc. The Concept Plan shall provide distinctive features to Biodiversity Conservation Park which will be unique from any other similar facility.

The concept plan should provide a framework for long term requirements and should focus on coexistence of living flora and fauna with the community. The Plan should also look at the Biodiversity Conservation Park as a tourist destination, and hence have to keep in mind the contemporary tourism expectations in terms of facilities and experiences. The proposed Biodiversity Conservation Park, is likely to play a multitude of roles, beyond the core objectives in research, conservation, collection, display and horticulture. Hence, the consideration and integration of the various spaces and experiences should be paramount in the concept planning process.

The Concept Plan should focus on

- Arrival and departure experiences
- Circulation patterns and the connections of different landscapes
- Positioning of infrastructure, roads, access paths, buildings and facilities to ensure holistic integration with the topographic and botanical context.

- Safety and security
- Flora and fauna that can be introduced
- Horticulture, floriculture, wilderness, forestation, wildlife, soft and hard interventions, etc
- Landscape and architectural elements both hard and soft
- Visual elements and signage
- External connectivity
- Digital experiences
- Unique interventions to position the Biodiversity Conservation Park benchmarking with international best practices

# The consultant should prepare atleast 2 Concept Plans for the project for review and approval by the Department

#### E. Detailed Master Plan

The Detailed Master Plan should focus on showcasing the State's flora focussing on several broad themes including taxonomy, ecology and geography, ornamental, conservation and ethnobotany. The Master Plan should address the spatial considerations by identifying elements that bring unique identity to Biodiversity Conservation Park. The Detailed Master Plan should consider

- Planning for key vistas
- Spatial enclosures and defining the views between them
- Circulation and sequencing of spaces including entry and exit
- Optimising visitor interaction with the gardens
- Minimise adverse impacts on fauna.
- Innovation in planning and design of infrastructure and built up works
- Sustainable and local materials- water, waste management and energy efficiency
- Areas for future development

#### The components of the Detailed Master Plan should include

- Comprehensive plan/layout delineating activity zones
- Gardens with favourable microclimates-displaying the diverse living collection to showcase Tamil Nadu's flora and its biological diversity
- Thematic spaces comprising of key collections and individual specimens of significance
- Conservation, Heritage, Education and Learning Centre;
- Visitor facilities and services-visitors hub, interactive displays, kiosks, commercial and events spacesenhancing accessibility and usability
- Architectural and landscape design including interpretive media.
- Landscape character (including hard and soft landscape elements, furniture) and visual values
- Cultural recreation, entertainment and exhibition venue, pavilion, amphitheatre, etc.
- Trails- nature trails, loop trails, canopy's with buffer zones
- Parking: public transport, management, emergency vehicle, private vehicle (including parking), bicycle and pedestrian, etc.
- Infrastructure—roads and paths, street lighting, services and access, water and waste water, solid waste management, etc.
- Safety and security components

The Master Plan should provide a framework for day-to-day operational and long-term decision making, facilitate prioritisation of activities, operational and maintenance requirements. The Master Plan should provide a framework for all future planning of the infrastructure enabling a long-term vision that places the proposed garden at the forefront of contemporary gardens world-wide.

• 3-D visual walkthrough of the park and its facilities.

#### F. Detailed Designs, BOQs and Estimates:

The consultant shall prepare detailed structural designs, detailed working drawings, architectural drawings for buildings, bill of quantities and cost estimates for all the components including infrastructure.

- Prepare the plan, design & architectural drawings for the proposed buildings for amenities and specialized infrastructure with all MEP systems including allocation and sizing of built-up areas for various activities and facilities.
- Infrastructure: road networks, pathways, pedestrian networks, storm water drainage network, streetlighting, comprehensive water supply system, sewerage system along with STP and recycling of treated waste water for green/landscaped areas, electrical distribution systems along with locations and capacities of transformers, solid waste management system, access control systems, entry/exit, parking, fire hydrant systems, etc.
- The detailing of architectural design & drawings (master plan, infrastructural plan, typical floor plans, elevations, unit & block layouts etc.) should be Good for bidding drawings. Besides this, the consultants shall provide the detailed specifications and functional requirements for all elements including MEPs.

The Consultant should also incorporate environmentally sustainable practices in the planning and design of infrastructure and built-up facilities to enable LEED Certification for the proposed Biodiversity Conservation Park.

The Consultant shall prepare technical specifications, working details, schedules, specifications and bill of quantities and analysis as per the existing SoR -PWD, Govt. of Tamil Nadu.

#### G. Business Plan & Financial Modelling and Project Structuring

The consultant shall develop an extensive financial model and business plan to capture all the techno-commercial as well as financial aspects of the Project both during the development as well as the operations phase to ensure the project is bankable. The Consultant shall also suggest the revenue streams and O&M charges to ensure operational sustainability.

The consultant shall project structures for development, financing and operation. The consultant shall prepare a financial model including revenues and cost streams for all the elements of the project.

The consultant shall develop a financial model to determine viability of proposed project, identification of the appropriate capital structuring, revenue model, Profit & Loss, Balance sheet and cash flows, Project IRR, Equity IRR and economic or social returns as applicable. The model may incorporate, as applicable, ticket sales, lease rentals and other revenue streams.

The Consultant shall also undertake sensitivity analysis by identifying most critical factors and determine their impacts on the project viability, including varying project costs and benefits, implementation period and combination of other factors.

#### H. Bid Process Management

Post receipt of all statutory approvals by the executing authority, assist executing authority in the Bid Process Management till the identification and signing of the contract with the contractors.

- a. For the administration of the bidding process, the consultant shall assist executing authority during the various procurement phases prequalification, bidding, negotiation and contract award in accordance with the formats and guidelines of the Tamil Nadu Transparency in Tenders Act 1998 and its Rules, TNIDB Act 2012 and its Rules & Regulations and other GoTN guidelines.
- b. The Consultant shall assist the executing authority in the Bid evaluation process, on the basis of provisions in bidding documents. The desired result shall be that the bid of selected bidder is the lowest, responsive and qualified bid and will provide value for money.
- c. The Consultant shall participate in pre-bid meetings and assist the executing authority in answering questions or issuing clarifications to the bidders. The consultant shall prepare minutes of meeting, addendum/corrigendum if any based on the clarification provided to the prospective applicants.
- d. The consultant shall prepare evaluation procedures with highest standard of efficiency, quality and integrity and assist the executing authority to evaluate the RFQ and RFP etc.
- e. The Consultant shall design and assist the executing authority to administer the bid evaluation process in an equitable and transparent way.
- f. The Consultant shall ensure that the evaluation process has been carried out as per the terms and conditions of the Bidding documents.
- g. The Consultant shall analyse the bids and recommend to the executing authority the least cost combinations for awarding contracts in terms and conditions of RFP document.
- h. The Consultants shall assist the executing authority in seeking any clarification from bidders and to analyze break down of price/cost/fees quoted by the bidders, if required.
- i. The Consultant shall prepare bid evaluation reports in close liaison with the executing authority.

  - a) The provisions of this Contract shall override all provisions of other documents comprising the Contract.
  - b) the provisions of the SC shall be subject to the Contract, but shall override all provisions of other documents comprising the Contract;
  - c) the provisions of the GC shall be subject to the Contract SC, but shall take precedence over all other documents comprising the Contract; and
  - d) the Appendices shall subject to each of the Contract, SC and the GC.

#### **II.** General Conditions of Contract

#### 1. General provisions

#### 1.1. **Definitions**

Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:

- a. "Applicable Law" means the all laws, bye-laws, rules, regulations, orders, ordinances, protocols, codes, guidelines, policies, notices, directions, judgments, decrees and any other instruments having the force of law in India as they may be issued and in force from time to time;
- b. "Affiliate" means, with respect to any Party, any other entity that, directly or indirectly:
  - i. (a) Controls such Party; (b) is Controlled by such Party; (c) is Controlled by the same person who, directly or indirectly, Controls such Party; and "Control" with respect to any person, shall mean: (a) the possession, directly or indirectly, of the power to direct or cause the direction of the management and policies of such person whether through the ownership of voting share capital, by agreement or otherwise or the power to elect more than one-half of the directors, partners or other individuals exercising similar authority with respect to such person; (b) the possession, directly or indirectly, of a voting interest of more than 50%; and the terms "Controlling" and "Controlled by" shall be construed accordingly;
- c. "Client/Authority" means the Party named in the Contract, who employs the Consultant;
- d. "Consultant" or "Consultants" means the party named in the Contract, who is employed as an independent professional firm by the Client to perform the Services;
- e. "Contract" means the Contract signed by the Parties, to which these General Conditions of Contract (GC) constitute a part, together with all other documents listed in this signed Contract;
- f. "Contract Price" means the price to be paid for the performance of the Services;
- g. "GC" means the General Conditions of Contract;
- h. "Government" means the Government of India (GOI) and the Government of Tamil Nadu (GoTN);
- i. "Local Currency" means Indian Rupees (INR);
- j. "Member", in case the Consultants consist of a joint venture of more than one entity, means any of these entities, and "Members" means all of these entities; "Lead Member" or "Member in Charge" means the entity specified in the SC to act on behalf of Each Member in exercising all the Consultants' rights and obligations towards the Client under this Contract;
- k. "Material Adverse Effect" means material adverse effect on (a) the ability of the Consultant to observe and perform any of its rights and obligations under and in accordance with the provisions of this Agreement and/or (b) the legality, validity, binding nature or enforceability of this Agreement;
- 1. Master Services Agreement (MSA) shall mean the same as "contract";
- m. "Party" means the Client or the Consultants, as the case may be, and Parties means both of them;
- n. "Performance Security" shall mean the irrevocable and unconditional bank guarantee provided by the Consultant from a scheduled Indian bank as guarantee for the performance of its obligations in respect of the Contract;

- o. "Personnel" means persons hired by the Consultants or by any Sub-consultant as employees and assigned to the performance of the Services or any part thereof;
- p. "Project" means "[name of assignment]";
- q. "SC" means the Special Conditions of Contract by which these General Conditions of the Contract may be amended or supplemented;
- r. "Services" means the work to be performed by the Consultants pursuant to this Contract as described in ToR;
- s. "Sub-consultant" means any entity to which the Consultants subcontract any part of the Services in accordance with the provisions of this contract; and,
- t. "ToR" means Terms of Reference
- u. "Work Order" means a specific directive or order to perform a defined scope for a defined duration and fee.
- v. "Corrupt Practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the selection process or in contract execution.
- w. "Fraudulent Practice" means a misrepresentation of facts in order to influence a selection process or the execution of a contract to the detriment of the Client, and includes collusive practice among consultants (prior to or after submission of proposals) designed to establish prices at artificial non-competitive levels and to deprive the Client of the benefits of free and open competition.
- x. "Coercive Practice" means impairing or harming, or threatening to impair or harm, directly or indirectly, any person or property to influence any person's participation or action in the Selection Process or the exercise of its rights or performance of its obligations by the Client under this Agreement;
- y. "Undesirable Practice" means (i) establishing contact with any person connected with or employed or engaged by the Client with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or (ii) having a Conflict of Interest; and
- z. "Restrictive Practice" means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Selection Process.
  - 1.2. Relationship between the Parties: Nothing contained herein shall be construed as establishing a relationship of master and servant or of principal and agent as between the Client and the Consultant. The Consultant, subject to this Contract, has complete charge of the Experts and Sub-consultants, if any, performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.
  - 1.3. Law Governing Contract: This Contract, its meaning and interpretation, and the relation between the Parties shall be governed by the Applicable Laws of India and shall be subject to the jurisdiction of the Courts at Chennai.
  - 1.4. Language: This Contract has been executed in English, as specified in the SC, which shall be binding and controlling language for all matters relating to the meaning or interpretation of this Contract.
  - 1.5. Notices: Any notice, request or consent made pursuant to the Contract shall be in writing and shall be deemed to have been made when delivered in person to an authorized representative of the Party to

- whom the communication is addressed, or when sent by registered mail, telex, telegram or facsimile to such Party at the address specified in the SC.
- 1.6. Location: The Services shall be performed at the site of the Assignment in accordance with the provisions of RFP and at such locations as are incidental thereto, including the offices of the Consultant.
- 1.7. Authorized Representatives: Any action required or permitted to be taken, and any document required or permitted to be executed, under this Contract by the Client or the Consultants may be taken or executed by the officials in the SC.
- 1.8. Taxes and Duties: Unless otherwise specified in the SC, the Consultants, Sub-consultants and their Personnel shall pay such taxes, duties, fees and other impositions as may be levied under the Applicable Law, the amount of which is deemed to have been included in the Contract Price.
- 1.9. Interpretation: In the Contract, unless the context otherwise requires:
  - 1.9.1. The singular includes the plural and vice versa and any word or expression defined in the singular shall have a corresponding meaning if used in the plural and vice versa. A reference to any gender includes the other gender.
  - 1.9.2. A reference to any document, agreement, deed or other instrument (including, without limitation, references to the Contract), includes a reference to any document, agreement, deed or other instrument as may be varied, amended, supplemented, restated, novated or replaced, from time to time.
  - 1.9.3. A reference to any document, agreement, deed or other instrument (including, without limitation, references to the Contract), means a reference to such document, agreement, deed or other instrument and to all appendices, annexes, schedules and parts attached or relatable thereto, all of which shall form an integral part of such document, agreement, deed or other instrument, as the case may be.
  - 1.9.4. A reference to any Applicable Law includes any amendment, modification, re-enactment or change in interpretation or applicability of such Law and a reference to any statutory body or authority includes a reference to any successor as to such of its functions as are relevant in the context in which the statutory body or authority was referred to.
  - 1.9.5. Where a word or phrase has a defined meaning, any other part of speech or grammatical form in respect of the word or phrase has a corresponding meaning.
  - 1.9.6. The words 'include' and 'including' are to be construed without limitation. The terms 'herein', 'hereof', 'hereto', 'hereunder' and words of similar purport refer to the Contract as a whole. Where a wider construction is possible, the words 'other' and 'otherwise' shall not be construed ejusdem generis with any foregoing words.
  - 1.9.7. In the Contract, headings are for the convenience of reference only and are not intended as complete or accurate descriptions of the content thereof and shall not be used to interpret the provisions of the Contract.

- 1.9.8. Any obligation not to do something shall be deemed to include an obligation not to suffer, permit or cause that thing to be done. An obligation to do something shall be deemed to include an obligation to cause that thing to be done.
- 1.9.9. The rule of interpretation which requires that a Contract be interpreted against the person or Party drafting it shall have no application in the case of this Contract.
- 1.9.10. References to a person (or to a word importing a person) shall be construed so as to include:
  - i. Individual, firm, partnership, trust, joint venture, company, corporation, body corporate, unincorporated body, association, organization, any government, or state or any agency of a government or state, or any local or municipal authority or other Governmental Authority (whether or not in each case having separate legal personality);
  - ii. That person's successors in title and assigns or transferees permitted in accordance with the terms of the Contract; and
  - iii. References to a person's representatives shall be to its officers, Personnel, legal or other professional advisors, subcontractors, agents, attorneys and other duly authorized representatives.

### 2. Joint and Several Liability: Collective action by Members

- 2.1. In the event the Consultant is a joint venture /consortium, the Members shall be deemed to be jointly and severally liable to the Client for the performance of this Contract. Without prejudice to the foregoing, the Client shall be entitled to terminate this Contract in the event of any change in the structure or composition of the joint venture/ consortium, including the Member in Charge ceasing to act as such. In the event the Consultant is a joint venture/ consortium, the Performance Security may be provided by any member; provided that such Performance Security shall mention the details of this Contract and shall indicate the JV/Consortium name.
- 2.2. In the event the Consultant is a joint venture /consortium, without prejudice to the joint and several liability of all the Members, each Member agrees that it shall exercise all rights and remedies under this Contract through the Member in Charge and the Client shall be entitled to deal with such Member in Charge as the representative of all Members. Each Member agrees and acknowledges that, notwithstanding anything to the contrary in the memorandum of understanding or any other such agreement or arrangement between the Members:
  - 2.2.1. any decision (including without limitation, any waiver or consent), action, omission, communication or notice of the Member in Charge on any matters related to this Contract shall be deemed to have been on its behalf and shall be binding on it. The Client shall be entitled to rely upon any such action, decision or communication from the Member in Charge;
  - 2.2.2. consolidated invoices for the Services performed by all the Members shall be prepared and submitted by the Member in Charge and the Client shall have the right to release payments solely to the Member in Charge and the Client shall not in any manner be responsible or liable for the inter se allocation of payments, works etc. among the Members;
  - 2.2.3. any notice, communication, information or documents to be provided to the Consultant shall be delivered to the authorized representative of the Consultant (as designated pursuant to Clause 1.5 of the GCC) and any such notice, communication, information or documents shall be deemed to have been delivered to all the Members.

#### 3. Commencement, completion, modification and termination of contract

- 3.1. Effectiveness of Contract: This Contract shall come into effect on the date the Contract is signed by both the Parties, or such other date as may be stated in the SC. The date the Contract comes into effect is defined as the Effective Date.
- 3.2. Commencement of Services: The Consultants shall commence the Services not later than the Effective Date specified in the SC.
- 3.3. Expiration of Contract: Unless terminated earlier pursuant to relevant clauses in this contract hereof, this Contract shall expire when Services have been completed and all payments have been made at the end of such time period after the Effective Date as shall be specified in the SC.
- 3.4. Modification: Modification of the terms and conditions of this Contract, including any modification of the scope of the Services or of the Contract Price, may only be made by written agreement between the Parties. Such modifications will be finalised based on mutual agreement between the selected consultant and authority and as per procedure laid out under the Tamil Nadu Transparency in Tenders Act, 1998 and RULES 2000 and as amended there on.

## 3.5. Force Majeure

- 3.5.1. Definition: For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a Party, and which makes a Party's performance of its obligations under the Contract impossible or so impractical to be considered impossible under the circumstances, and includes, but not limited to pandemic, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by government agencies. Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or such Party's agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected to both (A) take into account at the time of the conclusion of this Contract, and (B) avoid or overcome in the carrying out of its obligations hereunder. Force Majeure shall not include insufficiency of funds or failure to make any payment required hereunder.
- 3.5.2. No Breach of Contract: The failure of a party to fulfil any of its obligations under the Contract shall not be considered to be a breach of, or default under this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event:
  - i. has taken all precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and
  - ii. has informed the other party as soon as possible about the occurrence of such an event.
  - iii. has informed the dates of commencement and estimated cessation of such event of Force Majeure; and
  - iv. Informed the manner in which the Force Majeure event(s) affects the Party's obligation(s) under the Contract.
- 3.5.3. The Parties agree that neither Party shall be able to suspend or excuse the non-performance of its obligations hereunder unless such Party has given the notice specified above.

#### 3.5.4. Measures to be taken:

- a) A Party affected by an event of Force Majeure shall take all reasonable measures to remove such Party's inability to fulfil its obligations hereunder with a minimum of delay.
- b) The Parties shall take all reasonable measures to minimize the consequences of any event of Force Majeure.
- c) A Party affected by an event of Force Majeure shall notify the other party of such event as soon as possible, and in any case not later than fourteen (14) calendar days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give written notice of the restoration of normal conditions as soon as possible.
- 3.5.5. Extension of Time: Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure or any other reasons, which the client agrees.
- 3.5.6. Payments: During the period of their inability to perform the Services as a result of an event of Force Majeure, the Consultant, upon instructions by the Client, shall either:
  - a) demobilize, in which case the Consultant shall be reimbursed for additional costs they reasonably and necessarily incurred, and, if required by the Client, in reactivating the Services; or
  - b) continue with the Services to the extent reasonably possible, in which case the Consultant shall continue to be paid under the terms of this Contract and be reimbursed for additional costs reasonably and necessarily incurred.
- 3.5.7. In the case of disagreement between the Parties as to the existence or extent of Force Majeure, the matter shall be settled according to Clauses GCC 9.

### 3.6. Suspension of Agreement

The Client may, by written notice of suspension to the consultant, suspend all payments to the Consultant hereunder if the Consultant shall be in breach of this Contract or shall fail to perform any of its obligations under this contract, including the carrying out of the Services; provided that such notice of suspension (i) shall specify the nature of the breach or failure, and (ii) shall provide an opportunity to the Consultant to remedy such breach or failure within a period not exceeding 30 (thirty) days after receipt by the Consultant of such notice of suspension.

#### 4. Termination

- 4.1. By the client: The Client may terminate this Contract in case of the occurrence of any of the events specified in paragraphs (a) through (f) of this Clause. In such an occurrence the Client shall give at least thirty (30) calendar days' written notice of termination to the Consultant in case of the events referred to in (a) through (f); at least sixty (60) calendar days' written notice in case of the event referred to in (g):
  - a) if the Consultant fail to remedy a failure in the performance of its obligations hereunder, as specified in a notice of suspension pursuant to Clause 3.6;

- b) If the Consultant becomes (or, if the Consultant consists of more than one entity, if any of its members becomes) insolvent or bankrupt or enter into any agreements with their creditors for relief of debt or take advantage of any law for the benefit of debtors or go into liquidation or receivership whether compulsory or voluntary
- c) if, as the result of Force Majeure, the Consultants are unable to perform a material portion of the Services for a period of not less than sixty (60) days;
- d) if the Consultant fails to comply with any final decision reached as a result of arbitration proceedings pursuant to relevant clauses hereof;
- e) if the Consultant submits to the Client a false statement which has a material effect on the rights, obligations or interests of the Client. If the Consultant places itself in position of conflict of interest or fails to disclose promptly any conflict of interest to the Client;
- f) if the Consultant, in the judgment of the Client has engaged in Corrupt or Fraudulent Practices in competing for or in executing the Contract;
- g) if the Client, in its sole discretion and for any reason whatsoever, decides to terminate this Contract.
- 4.2. By the Consultants: The Consultants may terminate this Contract, by not less than thirty (30) day's' written notice to the Client, such notice to be given after the occurrence of the events specified in this clause:
  - i. if the Client fails to pay any money due to the Consultants pursuant to this Contract and not subject to dispute pursuant to relevant clauses hereof within forty-five (45) days after receiving written notice from the Consultants that such payment is overdue; or
  - ii. if, as the result of Force Majeure, the Consultants are unable to perform a material portion of the Services for a period of not less than sixty (60) days.
  - iii. within thirty (30) days, if the Client fails to comply with any final decision reached as a result of arbitration proceedings pursuant to relevant clauses hereof;
- 4.3. Cessation of Rights and Obligations: Upon termination of this Contract pursuant to actual Termination, or upon expiration of this Contract pursuant to relevant clause hereof, all rights and obligations of the Parties hereunder shall cease, except (i) such rights and obligations as may have accrued on the date of termination or expiration, (ii) the obligation of confidentiality set forth in relevant clause hereof, (iii) the Consultant's obligation to permit inspection, copying and auditing of their accounts and records, (iv) the rights of indemnity of the Client specified in the relevant clauses hereof and (v) any right which a Party may have under the Applicable Law.
- 4.4. Cessation of Services: Upon termination of this Contract by notice of either Party to the other pursuant to relevant clauses hereof, the Consultant shall, immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every reasonable effort to keep expenditures for this purpose to a minimum. With respect to documents prepared by the Consultant and equipment and materials furnished by the Client, the Consultant shall handover all assignment documents under procedure described in this contract.
- 4.5. Payment upon termination: Upon termination of this Contract, the Client will make the following payments to the Consultants:
  - i. Payments pursuant to relevant clauses for Services satisfactorily performed prior to the effective date of termination;

- ii. If the Contract is terminated pursuant to Clause 4.1 a), b), d), e) or f), the Consultant shall not be entitled to receive any agreed payments upon termination of the Contract. However, the Client may consider to make payment for the part satisfactorily performed on the basis of the quantum merit as assessed by it, in its sole discretion, if such part is of economic utility to the Client. Under such circumstances, upon termination, the Client may also impose penalty as per the provisions of relevant clauses of this Contract. The consultant will be required to pay any such penalty to Client within 30 days of termination date.
- 4.6. Disputes about Events of Termination: If either Party disputes Termination of the contract under relevant clauses hereof, such Party may, within forty-five (45) days after receipt of notice of termination from the other Party, refer the matter to arbitration under relevant clauses hereof, and this Contract shall not be terminated on account of such event except in accordance with the terms of any resulting arbitral award.

## 5. Obligations of the Consultants

5.1. General: The Consultants shall perform the Services and carry out their obligations hereunder with all due diligence, efficiency and economy, in accordance with generally accepted professional techniques and practices, and shall observe sound management practices, and employ appropriate advanced technology and safe methods. The Consultants shall always act, in respect of any matter relating to this Contract or to the Services, as faithful advisers to the Client, and shall at all times support and safeguard the Client's legitimate interests in any dealings with Sub-consultants or third parties. Since the Tamil Nadu Infrastructure Development Board is the nodal agency for development of Infrastructure in the State of Tamil Nadu, it must be continuously consulted, besides the Client, as a major stakeholder in the Project.

#### 5.2. Conflict of interest

- 5.2.1. The Consultant shall hold the Client's interest paramount, without any consideration for future work, and strictly avoid conflict with other assignments or their own corporate interests. Any breach of an obligation under Clause 5 shall constitute a conflict of interest ("Conflict of Interest"). The Consultant shall comply and shall ensure the Sub-consultants and Affiliates of the foregoing comply with the provisions of Clause 5 and any breach of such an obligation shall constitute an event of default by the Consultant for the purposes of this Contract. The Consultant shall promptly disclose any Conflict of Interest to the Client. For the avoidance of doubt, the Consultant agrees that a disclosure of any Conflict of Interest shall not in any manner whatsoever be deemed to cure such Conflict of Interest.
- 5.2.2. Consultants Not to Benefit from Commissions, Discounts, etc.: The payment to the Consultants pursuant to relevant clauses hereof shall constitute the Consultant's sole payment in connection with this Contract or the Services, and the Consultants shall not accept for their own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Contract or to the Services or in the discharge of their obligations under the Contract, and the Consultants shall use their best efforts to ensure that the Personnel, any Sub-consultants and agents of either of them, similarly shall not receive any such additional payment.
- 5.2.3. Consultants and Affiliates Not to Engage in Certain Activities: The Consultants agree that, during the term of this Contract and after its termination, the Consultants and their affiliates, as well as any Sub-consultant and any of its affiliates, shall be disqualified from providing goods,

- works or services resulting from or directly related to the Consultant's Services for the preparation or implementation of the project, unless otherwise indicated in the SC.
- 5.2.4. Prohibition of Conflicting Activities: Neither the Consultants nor their Sub-consultants nor the Personnel shall engage, either directly or indirectly, in any of the following activities:
  - i. during the term of this Contract, any business or professional activities which would conflict with the activities assigned to them under this Contract; and
  - ii. after the termination of this Contact, such other activities as may be specified in the SC.
- 5.2.5. The Consultant and its Personnel shall observe the highest standards of ethics and shall not have engaged in and shall not hereafter engage in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "Prohibited Practices"). Notwithstanding anything to the contrary contained in this Agreement, the Client shall be entitled to terminate this Agreement forthwith by a communication in writing to the Consultant, without being liable in any manner whatsoever to the Consultant, if it determines that the Consultant has, directly or indirectly or through an agent, engaged in any Prohibited Practices in the Selection Process or before or after entering into of this Agreement. In such an event, the Client shall forfeit and appropriate the performance security, if any, as mutually agreed genuine pre-estimated compensation and damages payable to the Client towards, inter alia, the time, cost and effort of the Client, without prejudice to the Client's any other rights or remedy hereunder or in law.
- 5.2.6. Without prejudice to the rights of the Client under Clause 5.2.5 above and the other rights and remedies which the Client may have under this Agreement, if the Consultant is found by the Client to have directly or indirectly or through an agent, engaged or indulged in any Prohibited Practices, during the Selection Process or before or after the execution of this Agreement, the Consultant shall not be eligible to participate in any tender or RFP issued during a period of 2 (two) years from the date the Consultant is found by the Client to have directly or indirectly or through an agent, engaged or indulged in any Prohibited Practices.
- 5.3. Confidentiality: The Consultants, their Sub-consultants, and the Personnel of either of them shall not, disclose any proprietary or confidential information, including information relating to reports, data, drawings, design software or other material, whether written or oral, in electronic or magnetic format, and the contents thereof; and any reports, digests or summaries created or derived from any of the foregoing that is provided by the Client to the Consultant, its Sub-Contractors and the Personnel; any information provided by or relating to the Client, its technology, technical processes, business affairs or finances or any information relating to the Client's employees, officers or other professionals or suppliers, customers, or contractors of the Client; and any other information which the Consultant is under an obligation to keep confidential relating to the Project, the Services, this Contract or the Client's business or operations without the prior written consent of the Client. Notwithstanding the aforesaid, the Consultant, its Sub-Consultants and the Personnel of either of them may disclose Confidential Information to the extent that such Confidential Information:
  - i. was in the public domain prior to its delivery to the Consultant, its Sub-Consultants and the Personnel of either of them or becomes a part of the public knowledge from a source other than the Consultant, its Sub-Contractors and the Personnel of either of them;
  - ii. was obtained from a third party with no known duty to maintain its confidentiality;

- iii. is required to be disclosed by Applicable Laws or judicial or administrative or arbitral process or by any governmental instrumentalities, provided that for any such disclosure, the Consultant, its Sub- Consultants and the Personnel of either of them shall give the Client, prompt written notice, and use reasonable efforts to ensure that such disclosure is accorded confidential treatment; and
- iv. is provided to the professional advisers, agents, auditors or representatives of the Consultant or its Sub- Contractors or Personnel of either of them, as is reasonable under the circumstances; provided, however, that the Consultant or its Sub- Consultants or Personnel of either of them, as the case may be, shall require their professional advisers, agents, auditors or its representatives, to undertake in writing to keep such Confidential Information, confidential and shall use its best efforts to ensure compliance with such undertaking.
- 5.4. Reporting Obligations: The Consultants shall submit to the Client the reports and documents specified in ToR, in the numbers including soft copy, and within the periods set forth in this contract.
- 5.5. Documents Prepared by the Consultants to be the Property of the Client: All plans, drawings, specifications, designs, reports, other documents and software submitted by the Consultants pursuant to this contract shall become and remain the property of the Client, and the Consultants shall, not later than upon termination or expiration of this Contract, deliver all such documents and software to the Client, together with a detailed inventory thereof. The Consultants may retain a copy of such documents and software. Restrictions about the future use of these documents and software, if any, shall be specified in the SC. The client has full rights for reproduction of documents.
- 5.6. Liability of the Consultants: Subject to additional provisions, if any, set forth in the SC, the Consultants' liability under this Contract shall be as provided by the Good Industry Practise/Applicable Law.
- 5.7. Insurance to be taken out by the Consultants: The Consultants (i) shall take out and maintain, and shall cause any Sub consultants to take out and maintain, at their (or the Sub consultants', as the case may be) own cost but on terms and conditions approved by the Client, insurance against the risks, and for the coverages, as shall be specified in the Special Conditions (SC), and (ii) within 15 (fifteen) days of receiving any insurance policy certificate in respect of insurances required to be obtained and maintained under this clause, the Consultant shall furnish to the Client, copies of such policy certificates, copies of the insurance certificates and evidence that the insurance premium have been paid in respect of such insurance. No insurance shall be cancelled, modified or allowed to expire or lapse during the term of this Contract. (iii) if the Consultant fails to effect and keep in force the aforesaid insurances for which it is responsible pursuant hereto, the Client will apart from having other recourse available under this Contract have the option without prejudice to the obligations of the Consultant, to take out the aforesaid insurance, to keep in force any such insurances, and pay such premia and recover the costs thereof from the Consultants, and the Consultants shall be liable to pay such amounts on demand by the Client. (iv) Except in case of Third Party Liabilities, the insurance policies so procured shall mention the Client as the beneficiary of the Consultants and the Consultants shall procure an undertaking from the insurance company in this regard, provided that in the event the Consultant has a general insurance policy that covers the risks specified in this Contract and the amount of insurance cover is equivalent to 3 (three) times the cover required hereunder, such insurance policy may not mention the Client as the sole beneficiary of the Consultant or require an undertaking to that effect.

# 6. Consultants' personnel

### 6.1. Description of Personnel

6.1.1. The titles agreed job descriptions, minimum qualifications and estimated periods of engagement in the carrying out of the Services of the Consultants' core team are described in this contract. The Key Personnel listed by title at Appendix B are hereby approved by the Client.

### 6.2. Removal and/or Replacement of Key Personnel

- 6.2.1. The Client will not normally consider substitutions except for reasons beyond the reasonable control of the Consultant such as retirement, death, medical incapacity among others of key personnel. Similarly, after award of contract the Client expects all the proposed key personnel to be available during implementation of the contract. The Client will not consider substitutions during contract implementation except under exceptional circumstances up to a maximum of 2 Key personnel other than Team Leader and that too by only equally or better qualified and experienced personnel. Any subsequent replacement of key personnel so replaced would call for reduction of remuneration by 2% of the Contract Value for the balance payment. Substitutions undertaken at the time of contract negotiations shall be counted while calculating the number of replacement substitutions under this clause. may be considered by the authority for situation beyond the reasonable control of the consultant and allowed based on merits of the case so determined by the Authority, subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority. The Authority may impose, at its discretion, reduction of remuneration by 5% of the Contract Value for the balance payment. The Authority reserves the right to instruct the Consultant to substitute the key personnel during negotiation/implementation stage. Such substitution shall not be considered for reduction of Contract Value. Inability of consultant to deploy Team Leader for the assignment will be grounds for Termination by Client.
- 6.2.2. If the Client finds that any of the Personnel have (i) committed serious misconduct or has been charged with having committed a criminal action, or (ii) have reasonable cause to be dissatisfied with the performance of any of the Personnel, then the Consultants shall, at the Client's written request specifying the grounds therefore, forthwith provide as a replacement a person with qualifications and experience acceptable to the Client.
- 6.2.3. The Consultant shall have no claim for additional costs arising out of or incidental to any removal and/or replacement of Personnel.

# 7. Obligations of the client

- 7.1. Assistance: Unless otherwise specified in the SC, the Client will use its best efforts to ensure that the Client will provide the Consultants, Sub-consultants and Personnel with authorisation letters as necessary to enable the Consultants, Sub consultants or Personnel to perform the Services:
  - 7.1.1. issue to officials, agents and representatives of the Government all such instructions as may be necessary or appropriate for the prompt and effective implementation of the Services;

# 8. Payments to the consultants

- 8.1. Payment terms: The total payment to Consultant including remuneration and other expenses shall not exceed the Contract Price and shall be a fixed lump sum fee including all staff costs, Sub-consultants' costs, printing, communications, travel, accommodation, and the like, and all other costs incurred by the Consultant in carrying out the Services. In addition to these, any conditions mentioned in the SC shall also be applicable to this contract. The Contract Price may only be increased if the parties have agreed to additional payments in accordance with relevant clauses hereof.
- 8.2. Payment relating to a particular stage shall be done after approval of the respective stage report. No payment shall become eligible for the next stage until the Consultant completes to the satisfaction of the Client the work pertaining to the preceding stage.
- 8.3. Currency: The price is payable in local currency i.e., Indian Rupees.
- 8.4. Payment for Additional Services: For the purpose of determining the payments due for additional services as may be agreed under relevant clauses for modification in this contract, the payment for the activities will be finalised based on mutual agreement between the selected consultant and authority and as per procedure laid out under the Tamil Nadu Transparency in Tenders Act, 1998 and RULES 2000 and as amended there on.
- 8.5. The Client shall pay the Consultant's invoices within the period specified in SC from the receipt of such itemized invoices or acceptance of the report/deliverable pertaining to the invoice by the Client, whichever is later.

#### 9. Settlement of disputes

- 9.1. Amicable Settlement: The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Contract or its interpretation.
- 9.2. Disputes Settlement: Any dispute between the Parties as to matters arising out of and relating to this Contract that cannot be settled amicably within thirty (30) days after receipt by one Party of the other Party's request for such amicable settlement may be submitted by either Party for settlement in accordance with the provision specified in the SC.

#### 10. Responsibility for accuracy of Assignment documents

#### 10.1. General

- 10.1.1. The Consultant shall be responsible for accuracy of the Designs, drawings, estimate and all other details prepared by him as part of these services. He shall indemnify the client against any inaccuracy in the work, which might surface during implementation of the Assignment. The Consultant will also be responsible for correcting, at his own cost and risk, the drawings including any re-survey/ investigations and correcting layout etc. if required during the execution of the Services.
- 10.1.2. The Consultant shall be fully responsible for the accuracy of plans and drawings. The Consultant shall indemnify the Client against any inaccuracy / deficiency in the designs and drawings noticed and the Client will bear no responsibility for the accuracy of the designs and drawings submitted by the Consultants.

# 11. Penalty

- 11.1. Penalties for delay & deficiencies: Any delay & deficiencies on part of the Consultant may attract penalty provisions in the form of fines, up to a maximum amount of 10% of the Contract Value, and/or termination by the Client. For period exceeding beyond stipulated time period, due to failure on the part of consultant, the consultant may be liable to pay to the client penalty at the rate of 1% of the Contract Value per week of delay subject to maximum of 10% of the contract value.
- 11.2. Encashment and appropriation of Performance Security: The Client shall have the right to encash and appropriate the proceeds of the Performance Security, in whole or in part, without notice to the consultant in the event of breach of this contract or for recovery of penalty specified in this Clause. In the event any portion of the Performance Security is appropriated by the client, then immediately following such appropriation, the consultant shall replenish the Performance Security within 1 (one) month of its appropriation, and in the event of default by the consultant, client shall have the right to take such steps as it may deem necessary, including termination of this contract.

# 12. Representation, warranties and disclaimer

- 12.1. The Consultant represents and warrants to the Client that:
  - 12.1.1.it is duly organised, validly existing and in good standing under the applicable laws of its Country;
  - 12.1.2. it has full power and authority to execute, deliver and perform its obligations under this Contract and to carry out the transactions contemplated hereby;
  - 12.1.3. it has taken all necessary corporate and other action under Applicable Laws and its constitutional documents to authorize the execution, delivery and performance of this Contract;
  - 12.1.4. it has the financial standing and capacity to undertake the Assignment;
  - 12.1.5. this Contract constitutes its legal, valid and binding obligation enforceable against it in accordance with the terms hereof;
  - 12.1.6. it is subject to laws of India with respect to this Contract and it hereby expressly and irrevocably waives any immunity in any jurisdiction in respect thereof;
  - 12.1.7. there are no actions, suits, proceedings, or investigations pending or, to the Consultant's knowledge, threatened against it at law or in equity before any court or before any other judicial, quasi-judicial or other authority, the outcome of which may result in the breach of or constitute a default of the Consultant under this Contract or materially affect the discharge by the Consultant of its obligations under the Contract.
  - 12.1.8. no representation or warranty by the Consultant contained herein or in any other document furnished by it to the Client contains or will contain any untrue statement of material fact or omits or will omit to state a material fact necessary to make such representation or warranty not misleading; and,
  - 12.1.9. no sums, in cash or kind, have been paid or will be paid, by or on behalf of the Consultant, to any person by way of fees, commission or otherwise for securing the Contract or for influencing or attempting to influence any officer or employee of the Client in connection therewith.

#### 13. Miscellaneous

- 13.1. Assignment and Charges
  - 13.1.1. The Contract shall not be assigned by the Consultant save and except with prior consent in writing of the Client, which the Client will be entitled to decline without assigning any reason whatsoever.
  - 13.1.2. The Client is entitled to assign any rights, interests and obligations under this Contract to third parties.
- 13.2. Indemnity: The Consultant agrees to indemnify and hold harmless the Client from and against any and all claims, actions, proceedings, lawsuits, demands, losses, liabilities, damages, fines or expenses (including interest, penalties, attorneys' fees and other costs of defence or investigation (i) related to or arising out of, whether directly or indirectly, (a) the breach by the Consultant of any obligations specified in relevant clauses hereof; (b) the alleged negligent, reckless or otherwise wrongful act or omission of the Consultant including professional negligence or misconduct of any nature whatsoever in relation to Services rendered to the Client; (c) any Services related to or rendered pursuant to the Contract (collectively "Indemnified matter"). As soon as reasonably practicable after the receipt by the Client of a notice of the commencement of any action by a third party, the Client will notify the Consultant of the commencement thereof; provided, however, that the omission so to notify shall not relieve the Consultant from any liability which it may have to the Client or the third party. The obligations to indemnify and hold harmless, or to contribute, with respect to losses, claims, actions, damages and liabilities relating to the Indemnified Matter shall survive until all claims for indemnification and/or contribution asserted shall survive and until their final resolution thereof. The foregoing provisions are in addition to any rights which the Client may have at common law, in equity or otherwise.
- 13.3. Governing Law and Jurisdiction: The Contract shall be construed and interpreted in accordance with and governed by the Applicable Law of India and subject to relevant clauses hereof and the SC, the Courts at Chennai, India shall have jurisdiction over all matters arising out of or relating to the Contract.

#### 13.4. Waiver

- 13.4.1. Waiver by either Party of any default by the other Party in the observance and performance of any provision of or obligations or under the Contract:
  - i. shall not operate or be construed as a waiver of any other or subsequent default hereof or of other provisions or obligations under the Contract;
  - ii. shall not be effective unless it is in writing and executed by a duly authorised representative of such Party; and
  - iii. shall not affect the validity or enforceability of the Contract in any manner.
- 13.4.2. Neither the failure by either Party to insist on any occasion upon the performance of the terms, conditions and provisions of the Contract or any obligation hereunder nor time or other indulgence granted by a Party to the other Party shall be treated or deemed as waiver of such breach or acceptance or any variation or the relinquishment of any such right hereunder.
- 13.5. Survival: Termination of the Contract (a) shall not relieve the Consultant or the Client of any obligations hereunder which expressly or by implication survive Termination hereof, and (b) except

as otherwise provided in any provision of the Contract expressly limiting the liability of either Party, shall not relieve either Party of any obligations or liabilities for loss or damage to the other Party arising out of or caused by acts or omissions of such Party prior to the effectiveness of such Termination or arising out of such Termination.

- 13.6. Notices: Unless otherwise stated, notices to be given under the Contract including but not limited to a notice of waiver of any term, breach of any term of the Contract and termination of the Contract, shall be in writing and shall be given by hand delivery, recognised courier, mail, e-mail, or facsimile transmission and delivered or transmitted to the Parties at their respective addresses specified in the SC. The notices shall be deemed to have been made or delivered (i) in the case of any communication made by letter, when delivered by hand, by recognised courier or by mail (registered, return receipt requested) at that address and (ii) in the case of any communication made by email, facsimile, when transmitted properly addressed to such telex number or facsimile number.
- 13.7. Severability: If for any reason whatever any provision of the Contract is or becomes invalid, illegal or unenforceable or is declared by any court of competent jurisdiction or any other instrumentality to be invalid, illegal or unenforceable, the validity, legality or enforceability of the remaining provisions shall not be affected in any manner, and the Parties will negotiate in good faith with a view to agreeing upon one or more provisions which may be substituted for such invalid, unenforceable or illegal provisions, as nearly as is practicable. Provided failure to agree upon any such provisions shall not be subject to dispute resolution under the Contract or otherwise.
- 13.8. No Partnership: Nothing contained in the Contract shall be construed or interpreted as constituting a partnership between the Parties. Neither Party shall have any authority to bind the other in any manner whatsoever.
- 13.9. Language: All notices required to be given under the Contract and all communications, documentation and proceedings which are in any way relevant to the Contract shall be in the language specified in the SC.
- 13.10. Exclusion of Implied Warranties etc.: The Contract expressly excludes any warranty, condition or other undertaking implied at law or by custom or otherwise arising out of any other agreement between the Parties or any representation by any Party not contained in the Contract.
- 13.11. Agreement to Override Other Agreements: The Contract supersedes all previous agreements or arrangements between the Parties, including any memorandum of understanding entered into in respect of the contents hereof and represents the entire understanding between the Parties in relation thereto.
- 13.12. Counterparts: The Contract may be executed in two counterparts, each of which when executed and delivered shall constitute an original of the Contract.

In the event no amicable resolution or settlement is reached within a period of thirty days from the date on which the above-mentioned dispute or difference arose, such dispute or difference shall be finally settled by arbitration. The arbitral tribunal shall consist of a sole arbitrator appointed by mutual agreement of the parties. In case of failure of the parties to 9.2 mutually agree on the name of a sole arbitrator, the arbitral tribunal shall consist of three arbitrators. Each party shall appoint one arbitrator and the two arbitrators so appointed shall jointly appoint the third arbitrator. The seat of arbitration shall be Chennai and the arbitration shall be conducted in the English language. The Arbitration and Conciliation Act, 1996 shall govern the arbitral proceedings. The award rendered by the arbitral tribunal shall be final and binding on the parties. The amount payable per arbitrator in arbitration case shall be as per Arbitration council rules and procedures. The Consultant shall, subject to the provisions of the Contract, indemnify the 13.2 Client for an amount not exceeding the value of the Contract for any direct loss

or damage that is caused due to any deficiency in services.
